

Task Force on National Greenhouse Gas Inventories (TFI)

28th Meeting of the Bureau of the Task Force on National Greenhouse Gas Inventories 1-2 September 2016, Minsk, Belarus

Summary of the meeting

The 28th Meeting of the Bureau of the Task Force on National Greenhouse Gas Inventories (TFB) was held on 1-2 September 2016, in Minsk, Belarus back-to-back with a scoping meeting for a Methodology Report(s) to refine the 2006 IPCC Guidelines for National Greenhouse Gas Inventories (29-31 August 2016). The meetings were hosted by the Government of Belarus and organised by the Technical Support Unit (TSU) of the Task Force on National Greenhouse Gas Inventories (TFI).

The TFB considered and discussed the progress of, plan and budget for the activities of IPCC TFI including work on a Methodology Report(s) to refine the *2006 IPCC Guidelines for National Greenhouse Gas Inventories* (*2006 IPCC Guidelines*), IPCC Emission Factor Database (EFDB), IPCC Inventory Software and cooperation with other organizations.

One of the main objectives of the 28th meeting of TFB was to consider the outcome of the scoping meeting including draft terms of reference (TOR), draft table of contents (TOC) and draft work plan for the Methodology Report(s). The outcome of the scoping meeting was agreed by TFB and submitted to the IPCC for consideration at its 44th Session to be held on 17-20 October 2016, in Bangkok, Thailand. The TFB, based on the outcome of the scoping meeting, decided to propose to the IPCC that

- The format should be one single Methodology Report comprising an Overview Chapter and five volumes following the format of the 2006 IPCC Guidelines for National Greenhouse Gas Inventories (2006 IPCC Guidelines)
- The title of the Methodology Report should be "2019 Refinement to the 2006 IPCC Guidelines for National Greenhouse Gas Inventories".

The TFB also reconfirmed that the refinement work will not revise the 2006 IPCC Guidelines, but will provide an update, supplement and/or elaboration of the 2006 IPCC Guidelines where gaps or out-of-date science have been identified. The outcome of this refinement work will not replace the 2006 IPCC Guidelines, but will be used in conjunction with the 2006 IPCC Guidelines.

The TFB highlighted that other issues which were identified in the technical assessment and recommended as to be addressed by other means such as Frequently Asked Questions at TFI website and EFDB should be addressed as early as possible in parallel with production of the Methodology Report.

It was also noted that the issues recommended for the EFDB should be prioritized in collection and inclusion of data into the EFDB. There was also discussion on further improvement of usability of the IPCC Inventory Software (e.g. having in languages other than English and open source code) and the TFB requested TSU to explore the possibilities.

The TFB welcomed the activities implemented under Memorandum of Understanding (MoU) between the UNFCCC Secretariat and the IPCC Secretariat (signed in January 2016). One of the core activities of the MoU is training workshops on the *2006 IPCC Guidelines*. Three regional workshops had been planned by the UNFCCC Secretariat to be organized in cooperation with TSU in 2016, two of which had taken place (in Africa region and in Latin America and Caribbean region) and one was going to take place (in Asia-Pacific and Eastern European region) in the week subsequent to this meeting of TFB.

The meeting was closed by TFI Co-chairs thanking all participants, and the Government of Belarus for hosting the IPCC TFI meetings and excellent arrangements.
