Norway	Rejected	It is not practical to make the terminology identical to that used in the WG reports, because the many words have been differently used by the inventory compiler community than the other WGs community. It is more important to ensure consistency in the definitions of terms with the common practice followed for many years in the inventory compiler community. Also, it is not necessarily helpful to include all terms in the overarching Glossary, because including all of very sector- or category-specific words will increase the volume of Glossary which may well make it less easy to use.
