Rocio Danica Condor Golec	Rejected	As clarified in Section 6 of Overview Chapter, the 2019 Refinement provides methods for estimating emissions (and removals as appropriate) for each gas in mass units. It does not recommend any specific metrics (e.g., GWP values) to calculate emission estimates in CO2 equivalent units. This is completely consistent with the principle of 2006 IPCC Guidelines. Section 8.2.2 in Vol.1 of 2006 Guidelines explains that gases covered by 2006 Guidelines are those for which GWP values are provided in TAR, but does NOT suggest GWP values in TAR should be used to calculate emissions in CO2 equivalent units.
